

STUDENTS' COMPETENCE IN USING DETERMINERS (THIS, THAT, THESE, THOSE) AT SMP NEGERI 2 KOTA TERNATE

Abstract: The purpose of this study was to determine students' competence in using determiner (This, that, these, those) in class VII students of SMPN 2 Kota Ternate in the 2025-2026 academic year. The population in this study were class VII students in the odd semester of SMPN 2 Kota Ternate in the 2025-2026 academic year. While the number of samples in this study was 30 respondents collected using purposive sampling. This study used a quantitative descriptive method. Data were collected using 30 multiple choice questions, matching and essays. The researcher found that no students were in the very poor category, four students (13.33 %) were in the poor category. Then there were seven students (23.33%) who were in the fair category, ten students (30.33%) were in the fairly good category, seven students (23.33%) were in the good category, one student (3.33%) was in the quite very good category, and one student (3.33%) was in the excellent category. In summary, the average score for students in using determiner (this, that, these, those) sentences was 69.4. This indicates that students' competence in using determiner (this, that, these, those) sentences in the even semester of seventh grade students is still fairly good.

INTRODUCTION

English is known as one of the international language in the world. It is a tool or an aid to communicate with other people. That means, grammar rules are very important for someone to learn for language mastery. 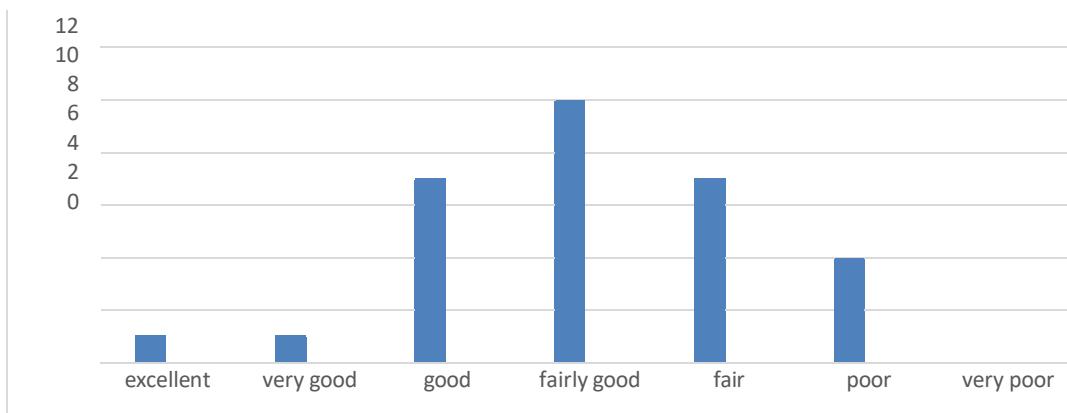

Discussion

Based on the observation of students' competence in using determiners (this, that, these, those), it was found that most students at SMP Negeri 2 Ternate had a fairly good understanding of the material, with an average score of 69.4 which is in the "fairly good" category and the percentage of students showed at (30.33%) which means in the fairly good category, this reflects that the majority of students reached a high level of fairly good in understanding and applying the material of using determiners (this, that, these, those). These results can be compared with several previous studies that also examined students' errors or abilities in using determiners in English.

However, Research by Hasriyanti, et al. (2023) shows that the most dominant type of determiner usage error is in the use of articles (a, an, the). This research was conducted on final-year university students, who have a higher level of learning compared to junior high school students. Even so, these findings indicate that problems in the use of determiners, especially articles, are still an obstacle even at the university level. This indicates that learning determiners requires special attention from an early age so that errors are not carried over to higher levels of education.

In addition, research by Sari (2019) at the junior high school level also provides a similar picture to this study. In her research on seventh grade students at SMP Negeri 1 Pangean, it was found that the average ability of students in using determiners was 70.21, which was also in the good category. This score is quite comparable to the average score of students in this study, which is 69.4 which is in the fairly good category. This similarity indicates that junior high school students' ability to use determiners is still at an intermediate level and needs to be improved, especially in the context of using demonstratives such as "this, that, these, those".

CONCLUSION

The study reveals that 30 students in class VII-7 of SMPN 2 Ternate have fairly good abilities in using determiners (this, that, these, those). Based on the results of the data analysis that has been carried out in the findings section, it can be seen that the total scores of students in using determiners (this, that, these, those) in multiple-choice questions, Matching, and essay terms of both percentage and average scores is 69.4.
